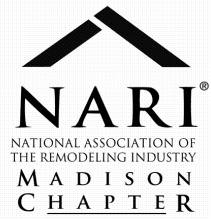

#### Insurance

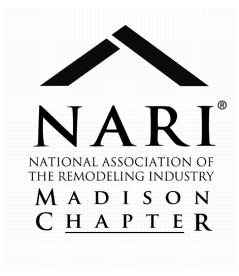
