

# **NARI of Madison Sub-Contractor of the Year Award**

The NARI of Madison Sub-Contractor of the Year Award recognizes NARI of Madison member Sub-Contractors who have demonstrated a strong commitment to NARI, the professional remodeling industry and the community or communities in which they do business.

1. Nominations must be submitted with the proper Entry Form and may be made by any member of NARI of Madison, including those for whom the sub-contractor has performed work.
2. Judging will be based on the nominee's involvement in any or all of the following activities:
  - a. Customer service and communication
  - b. Teamwork practices with the consumer, contractor and other sub-contractors
  - c. Problem solving abilities
  - d. Exemplary Workmanship
  - e. The support and promotion of their local NARI chapter
  - f. The recruitment of new NARI members
  - g. Community service projects
3. A maximum of one award may be presented each year at the judges' discretion.
4. A panel of judges selected by the Awards Committee will review all entries.
5. The nomination should include, but is not limited to, completed projects performed for the nominating member, written support of past and/or present contractor members, material supporting the nominee's participation and accomplishments with NARI at the national and/or local level.
